1. Call to Order

The meeting was called to order at 1:02 p.m.

2. Land Acknowledgement

We acknowledge that we are on land and surrounded by water, originally inhabited by Indigenous Peoples who have travelled this area since time immemorial. This territory is within the lands honoured by the Wampum Treaties; agreements between the Anishinaabe (Ah-nish-e-naa-bay), Haudenosaunee (Hoe-den-oh-show-nee), Lenni (Len-eh) Lenape (Le-naw-pay) and allied Nations to peacefully share and care for the resources around the Great Lakes. Specifically, we would like to acknowledge the presence of the Three Fires Confederacy, Ojibwe (Oh-jib-way), Odawa (Oh-dah-wah), Potawatomi (Paw-taw-watt-ohme) and Huron/Wendat (Wen-dat) Peoples. - 6. Special Education Presentation
  - C. Mills met with T. McCarthy and K. McKinley to brainstorm topics for upcoming meeting. He thanked M. Wilcox for hosting us today.
  - Budget Survey presented by S. Maheux. The Ministry requires SEAC be involved in the budget, we are starting a lot earlier this year. We currently have a \$9 million deficit. The pressures relate to special education, transportation, occasional cost, inflation. It is important to get feedback from committees, as well as the public. We will be releasing 2 different surveys this year. I really encourage SEAC to provide feedback to the survey as a committee. We are looking for suggestions for potential savings. The Board will submit a deficit recovery plan to the Ministry, everything is being looked at. 80% of the Board's budget is wages and benefits. There are still a lot of unknowns. Over the next month we need to think about what is important as a group for Special Education.
  - Brain Computer Interface, K. Smith, from the John McGivney Children's Centre School Authority and L. Brode, Education Coordinator, presented and demonstrated the brain computer interface. JMCC has been trialing and using this technology successfully for a few of their students and the GECDSB is partnering with Holland Bloorview Kids Rehab to trial it with a select elementary and secondary students.
