Principal Presentation - Elementary Math Initiative by Gene Petrusenko, Vice-Principal of Belle River Public School.

- Presentation was given about a math initiative program that strengthens partnerships between parents and students.
- It extends student learning from the classroom to the home.
- Questions are sent home with the students to share with their parents.
- The answer sheet is included as well as a blog address.
- Surveys are used to track progress.
- It's not about the right answer - it's about the reasoning and articulation involved in answering the questions.
- Kits are made from materials that the school already has.
- Parent volunteers are used to oversee the project.

Financial Reporting Update by Leah Beneteau

- A presentation regarding policies and procedures for monetary issues was viewed.
- The principal is responsible for all school generated funds and any funds raised by School Council. All assets purchased legally belong to the School Board.
- AP-BA-13 should be made available to every individual involved with school generated funds.
- All funds collected should be recorded on a Cash Receipts Voucher.
- Financial reports and bank reconciliations should be read at parent council meetings.
- Chair should ensure that all records are complete and financial reports are done.

Portal Update by Superintendent John Howitt

- A presentation about the progress of the Portal was viewed.
- Staff and teachers need to be on before we can add the parents. Teachers and staff are in the process of being trained.
- Schools need to be up and running first.
- The Riverside Family of Schools is participating in a pilot project.
- The parent side of the Portal will come from this pilot project and will hopefully be done in the fall.

Multicultural Literacy Night by Katrina Elchami, Chair at Roseland Public School

- A presentation was made regarding Multicultural Literacy Night at Roseland Public School.
