## **GREATER ESSEX COUNTY DISTRICT SCHOOL BOARD PLAN IN ACCORDANCE WITH ONTARIANS WITH DISABILITIES ACT (ODA) FOR THE YEAR SEPTEMBER 2023 TO AUGUST 2024**

The Ontarians With Disabilities Act 2001 requires that all public organizations such as municipalities, school boards, hospitals, universities, and colleges to prepare a plan that identifies measures the organization has taken to identify, remove and prevent barriers to persons with disabilities and consult with persons with disabilities and others in preparing the plan.

The Accessibility for Ontarians With Disabilities Act 2005 (AODA) empowers Regulation 191/11 “Integrated Accessibility Standards” that provides direction for the following areas:

1. Information and Communication Standards
2. Employment Standards
3. Transportation Standards
4. Design of Public Spaces Standards (Accessibility Standards for the Built Environment)
5. Customer Service Standards

The Greater Essex County District School Board (GECDSB) must publish this plan by September 30<sup>th</sup> of each year in accordance with the Ontarians With Disabilities Act. Every year the Ontarians With Disabilities Act Committee must update the plan for the next year.

***2 - Renovations completed at elementary and secondary schools during 2022/23 school year:***

<b><u>Name of School</u></b>	<b><u>Renovations completed during 2022/2023 school year</u></b>
Amherstburg PS	Renovation of universal washroom including installation of auto door opener.
Anderdon PS	Installation of automatic door operators at two exits to the school, installation of exterior concrete ramp.
Central PS	New barrier-free washroom, installation of 2 new auto operators.
Centennial Central PS	Replacement of exterior barrier-free ramp to meet current building code.
Colchester North PS	Installation of automatic door operator. Creation of a universal washroom.
Easter Mersea PS	New main entrance with new automatic door operator. Creation of a universal washroom.
Gosfield North PS	Upgrade of the barrier-free washroom and creation of a universal washroom.
Tecumseh Vista PS	New accessible entrance and the installation of an automatic door operator.
Queen Elizabeth PS	Upgraded existing east parking lot to include barrier-free access by removing existing stairs and constructed a barrier-free ramp.
Walkerville Collegiate	Installation of automatic door operator at main entrance / staff entrance.
Eastwood PS	Renovation to create a barrier-free washroom.

**3 - Renovations planned at elementary and secondary schools for completion during the 2023/24 school year:**

<b><u>Name of School</u></b>	<b><u>Renovations planned during 2023/2024 school year</u></b>
David Suzuki PS	Conversion of existing change room washroom to barrier-free washroom.
Forest Glade / Forest Glade PLC	Washroom upgrades which include barrier-free upgrades.
General Brock PS	New barrier-free washroom.
Glenwood PS	Barrier-free washroom upgrades (current barrier-free washroom does not meet building code).
Harrow PS	Washroom upgrades which include barrier-free upgrades.
Hugh Beaton PS	New barrier-free washroom, washroom upgrades which will include barrier-free upgrades, relocation of existing office (currently on second floor) to the main entrance creating barrier-free access to the office space.
Queen Elizabeth PS	New barrier-free washroom.
Riverside SS	Special Education upgrades which include a barrier-free washroom upgrade (current barrier-free Washroom does not meet building code).

**Information & Communication:**

During the 2021-2022 school year, Communications Team & ITS team migrated board and school websites to a new platform to meet AODA requirements. The AODA scanning tool will be used on new sites to ensure compliance with materials included on board and school websites.

**Employment Standards:**

During the 2022-23 school year, the Board undertook an Employment Systems Review to create a more diverse workforce by evaluating formal and informal policies and practices related to the recruitment, hiring and selection processes. A plan to adopt recommendations is currently being developed.

Note: Cleaning protocols will be continued to ensure that high touch surfaces, such as elevator buttons and automatic door opener buttons are disinfected. Hand sanitizing stations continue to be maintained at all building entrances.
