the programs stay because I don't think that my son would have had the same opportunity at any other high school and he is an amazing person partly because of those programs. I just want to express that concern to you and hope that the Dougall family is still involved in terms of communication. Please make sure the programs stay the same for Century.

Q –A request has been made that there be a Special needs consultant on this process. R- Dr. Pyke, Superintendent of Special Education will be actively involved in this process but sent her regrets this evening.

Q- I have been involved with public meetings for a study the school board did call the "white paper". Are we going to resurrect that and take a look at any of the recommendations? R – No I don't think that we will be resurrecting any of the white paper at this time.

7. Closing Comments and Adjournment

Superintendent Lyons reminded the audience of the three more community meetings. He emphasized to the audience that the committee can only make recommendations; trustees will make the final decision.

There being no further questions, the meeting adjourned at 7:36 p.m.

6. Questions relating to the process

Q- Why were trustees not consulted before the removal of Benson Public School, Dougall Public School and Taylor Public School from the PARC committee?

R – The committee had a lengthy discussion (over one hour) regarding the mandate of the PARC and the viability of those schools in achieving solutions. The committee held ballots and determined to have those three school exempted from the PARC.

Q- Will that ever go back to Trustees?

R- No, that is not a trustee decision, but a decision of the PARC committee.

Q- My daughters currently attend Benson, who is eligible to attend the new school? R- The decision was made by the Trustees last May. Benson Public School and Taylor Public School will be closed and a new school will be built on the Taylor site. Anyone that lives in those two schools boundaries will be able to attend the new school.

Q- Where will my daughters go to school in September?

R- Your daughters will attend Benson Public School. We are at the point where an architect has been selected and plans are being developed on for the design of the new school. We are hoping for a September 2013 opening.

Q - Can the three schools that have been excluded still participate in the PARC? R-The three schools have been excluded from the PARC committee can still provide input. Notifications of any discussions affecting Benson Public School, Dougall Public School and Taylor Public School will be sent home with students. Even though they have been excluded from the committee work they haven't been excluded from the process.

Q – Century is part of this study. I didn't see any of the data you had on the other secondary schools i.e. Herman?

R – We selected a few schools for examples to show the cost per pupil. We didn't include everybody.

Q- There are other parents here from the Elementary level. Our son is at Century so he is Secondary. Are Elementary and Secondary going to be separated?

R – At this time there are no decisions made. Forster is a Secondary school as well and is still in the accommodation study. We haven't even started to brainstorm ideas of what solutions there would be to help solve the two given mandates.

C- Century is a very specialized school for hands on students and I would like to bring forward just to ensure that those types of accommodations will be available if they are moved i.e. the kitchen, automotive those types of facilities that are not available at all schools.

C- I completely understand why the school board is looking at all the schools in terms of capacity issues. I just want to share these parents' exact same concerns. As a Century parent having the opportunity to watch my child grow and succeed to make sure those programs and the quality of

Why the Forster Family was chosen for the PARC:

- Continues to have some of the oldest buildings in the Board
- Has one of the lowest utilization rate in the Board
- Enrolment projections continue to remain low for the next twenty years
- The current situation is not sustainable
