# PARC Final Report for the Forster Family And Century Schools

# Purpose of this Report:

This is the final report from the Program Accommodation Review Committee (PARC) for the Forster Family of Schools. This report contains the findings and recommendations of that committee. It was presented to the school communities of J.E. Benson P.S., Century S.S., Dougall P.S., General Brock P.S., J. L. Forster S.S., Marlborough P.S. and Dr. H.D. Taylor P.S. during the PARC's fourth public meeting on Monday, June 4<sup>th</sup>, 2012 at 5:30 PM.

All comments and feedback received from each of the PARC's public meetings have been considered while completing this final report.

The committee is presenting the report to Trustees at a special meeting of the Board on June 25, 2012 at 5:30 PM. This report includes a summary of events to date to provide a contextual background for the reader.

## Background:

The Forster Family of Schools' Program and Accommodation Review Committee was established as a result of the following motion approved by trustees at the regular Board meeting of October 18, 2011:

## THAT THE SUPERINTENDENT RESPONSIBLE FOR ACCOMMODATIONS CONDUCTS A PARC STUDY OF THE FORSTER FAMILY OF SCHOOLS AND INCLUDE CENTURY DUE TO ITS GEOGRAPHICAL LOCATION TO:

- ADDRESS CAPACITY ISSUES AND AGING INFRASTRUCTURE NEEDS WITHIN THE FORSTER FAMILY OF SCHOOLS,
- CONTINUE OUR INVESTIGATION FOR A PERMANENT FRENCH IMMERSION SITE, IN ACCORDANCE WITH BOARD DIRECTION FROM THE SOUTH WINDSOR PARC.

## **Composition & Role of the Program Accommodation Review Committee**

As required under the GECDSB's Policy and Regulation AD-01, a Program Accommodation Review Committee (PARC) was established to lead the review and analysis regarding the possible change in student accommodation and to make recommendations on the accommodation options for the Forster Family of Schools. Due to its geographic proximity, it was decided that Century Secondary School be included in this review.

- $\checkmark$  Maintain a high school on the west end of the city.
- Maintain the specialized high school programs offered for high school students with identified learning exceptionalities.
- ✓ Reduce excess student spaces.
- $\checkmark\,$  Reduce renewal costs to the GECDSB.
- ✓ Fulfill the mandates of the PARC.

# Forster Family of Schools PARC Final Recommendations and Analysis:

The committee has determined that two of the 37 options presented and discussed at the committee meetings are viable, and offer these two recommendations unanimously to the Board of Trustees and the Director of Education for the Greater Essex County District School Board.

## **Recommendations**:

- (a) Close Marlborough and Forster Schools and the temporary French Immersion site at Giles Campus:
  - Construct a new dual track K-12 facility on the Marlborough site to accommodate Marlborough, Forster and Giles Campus students. All boundaries remain as current.

Close Century School:

• Adaptive Basic students transition to Western Secondary School. All other Century students transition to home schools.

- (b) Close Forster and Century Schools:
  - Create a neighbourhood school on the former Century site with applicable programming to accommodate all Forster and Century students.

Close Marlborough School and temporary French Immersion site at Giles Campus:

• Construct a new dual track K-8 facility on the Marlborough site to accommodate Marlborough and Giles Campus students. All boundaries remain as current.
