Report of Community Meeting 2 held at McCallum School



THAT THE SUPERINTENDENT RESPONSIBLE FOR ACCOMMODATIONS CONDUCTS A PARC STUDY OF THE HERMAN FAMILY OF SCHOOLS TO:

- i. ALLEVIATE OVER CAPACITY ENROLMENT AT McCALLUM
- ii. REDUCE THE NUMBER OF EMPTY STUDENT SPACES AND IMPROVE THE UTILIZATION RATES WITHIN THE FAMILY OF SCHOOLS.

1. Call to Order and Welcome

The meeting was called to order at 7:00 p.m. by Superintendent Lyons. He welcomed everyone to the meeting and introduced Nancy Drew, Principal of McCallum School.

Superintendent Lyons noted that this is the second of four meetings that will take place in the next few months.

2. Introductions

Superintendent Lyons introduced Chairperson Bailey, Director Kennedy, Area Superintendent Paul Antaya, as well as Al Cook, Manager of Facility Services.

3. Background

Every year the Director presents an annual accommodation report to our Trustees. In October, 2011, Trustees approved a motion that we conduct a PARC study of the Herman Family of Schools.

The Committee has many tasks before them. They will look at the enrolment trends, other relevant data, student programming in each school and hear community input before writing final recommendations to the Director. Ultimately, the trustees will make the final decision.

4. School Information Profile

Kelly Schwab, Kim Lunansky and Derek Demonte reviewed the powerpoint presenation. See attached. Al Cook, Manager of Facility Services reviewed the FCI which is an international standard used to compare buildings based on their condition. The FCI takes into consider all renewal needs of a building (ie. roof, boiler etc.) The higher the FCI number the higher the replacement needs.

Q: What will happen with Delta Chi daycare if Coronation School is closed?

Why is this happening?

At the October 18, 2011 regular meeting of the Board, Trustees approved the following recommendation:

That the Superintendent responsible for accommodation conducts a PARC Study of the Herman Family of Schools to:

- Alleviate over capacity enrolment at McCallum
- Reduce the number of empty student spaces and improve the utilization rates within the family of schools.

Enrolment


- It is important to note that the vast majority of the province's school boards are experiencing significant drops in enrolment.
- Declining enrolment remains the biggest financial challenge for our school board as revenue is directly tied to the number of students within the GECDSB.
- The Herman Family of Schools is an example of this trend, with continued declining enrolment that is predicted to stabilize. With the exception of one school, which is experiencing enrolment growth. Other issues such as empty student spaces and infrastructure renewal needs are also considerations.



Value of the schools: Community

- All of the Herman Family of schools participate actively in a variety of local events, festivals and other activities. Which include: greening projects for local parks, ordering from local restaurants, partnerships with local banks, churches, libraries, grocery stores, high schools, college, and university, schools offer places for community service hours, opportunities for volunteering
- All of the schools have facilities that are used by local organizations and community partners (e.g., rentals, green space, parking for events)
- The schools are all accessible from main routes and are well connected to surrounding neighbourhoods
- They are all GREAT places for kids to be!

Value of the schools: Local economy

- All of the Herman Family of Schools have developed partnerships with local/area merchants, service clubs (e.g., Legion, Optimist Club, Food Bank) and other organizations
- All of the schools participate in co-op/work experience/OYAP placement programs and have employees that live in their school community
- HFS provides a financial injection to many local and surrounding businesses.

Value of the schools: Activities

- Herman: The Urban Helping Hands Program
- <u>Coronation:</u> University, and Windsor Housing, Safe Schools, Clean Sweep, local Churches and Pharmacy, greening areas, Goodfellows, local restaurants
- <u>Davis:</u> Friends of Fountainbleu, Foutainbleu Library, Adopted by Indigo and Windsor Spitfires, Kids Alliance, Community Outreach for Seniors, ERCA and greening, OSNP, local grocery stores and restaurants
- <u>Maxwell:</u> Community service hours, OSNP, restaurants and grocery stores as well as donations to St. Mary's Food Cupboard.
- McCallum: Order food from local vendors and restaurants, ties with Herman, partnership with Community Living.
- McGregor: St. Clair College, Drouillard Place, food drives, local grocery stores, community service hours, ordering food from local vendors, big brothers/sisters and Hospice
- Roseville: Big brothers/sisters, hospice, OFIF, OSNP, Local Bank, Church, Spitfires and Grocery stores.
