- i. ALLEVIATE OVER CAPACITY ENROLMENT AT McCALLUM
- ii. REDUCE THE NUMBER OF EMPTY STUDENT SPACES AND IMPROVE THE UTILIZATION RATES WITHIN THE FAMILY OF SCHOOLS.

#### 1. Call to Order and Welcome

## 6. Questions

Questions were answered throughout the meeting and are noted.

Further clarifications were made.

Q. How can we compare secondary FCI data to elementary; should we be comparing FCI to other secondary schools within the system?

- A. Elementary renewal costs are usually less expensive. The secondary school replacement costs shown in the powerpoint at the first community meeting were an illustration of the costs of empty student spaces and were a comparison of schools chosen randomly across the system.
- Q. If an elementary school is at capacity, can the board refuse to enroll a student in that school? The coterminous board may close some of its schools and there is a potential that some of those students could transfer to the public board.
- A. If a student lives within a particular school's boundary then we cannot refuse enrolment. Hypothetically, we could have over 100 students from the separate school wanting to go to one of the public board's schools. We cannot use that type of information when considering solutions to our current mandate, as it is not factual, merely hypothetical.

#### 7. Next steps

We will plan for the March 21 committee meeting at Davis at 4:30 to be a lengthier meeting. We will provide a light dinner.

The meeting adjourned at 6:30 p.m.
