Hello Mr. Awender,

I would like to take this opportunity to again thank you for your commitment to building a high-quality future of education to students in this region of Ontario. I appreciate all the hard work and dedication that you choose to steer towards our children. I have faith that you truly desire to do what is right for our future.

As you consider the mountains of feedback you've received in the past months regarding your upcoming vote on June 8, I ask you to listen and respond to this, my last email to you.

I am a parent of two children at Gore Hill Public School. Not by technicalities, but by choice. When we arrived in Ontario 16 months ago, I researched and interviewed many parents, I personally toured the local schools, sat down with the principals, and discussed all the benefits that each school had to offer. I was not content just to send my children to some random school without fulling knowing the extent to which they would be benefited from an educational and relational perspective. After my research, I was utterly convinced that Gore Hill School is someplace special, completely irreplaceable. I saw something in these students, both past and present, and in their families, that I did not see in other places. I saw a beautiful respect for individuality - one on one compassion and learning from the teacher to the student, which in turn has built such an incredible boost of confidence in EACH CHILD. And thus, the student environment is such that is hopeful, positive, successful. I can confidently say that the reason why I can recognize these things is because I grew up in a small town in western Canada whose school was very similar to Gore Hill in many ways. These qualities encompassed my school as well. And out of this small county school have come some of the most brilliant students that this country has seen - lawyers, doctors, physiotherapists and chiropractors, pilots, engineers, politicians, and so much more. Because in this amazing, irreplaceable school, there was an acceptance of each child. There was much creativity in outdoor learning, there was one-on-one teacher/student relationship, there was a passion for the success in each individual child.

Remember the reasons why we choose to send our children to school... not to lag behind in a sea of other faces, but to excel in who they were created to be... to become our future scientists, doctors, politicians! We must fight for this future.

Remember, also, other practical reasons: that parents who choose to live in the country also wish for their children to attend county schools. Lastly, I close this letter to simply implore you... please reconsider the suggested closing of Gore Hill Public School. Please do not make a decision that will later regret. Consider the future of our children, not just the current financial situations. I trust that you truly do care about these children entrusted to you, and that you will choose wisely.

### Dear Trustees,

This accommodation study seems to be trying to do too many things in one brush stroke. You are trying to begin a dual track French Immersion program while at the same time attempting to consolidate schools. Any families interested in the French Immersion program could potentially be turned off by the prospect of starting at one school and transferring to another a few years in. Also, if the French Immersion program is successful, and Gore Hill is combined into a 550 student school with MD Bennie, will there even be enough room for that new program as it flourishes and grows by a grade or more each year?

It has become quite clear that town families want a town school, and country families want a country school. If a boundary change is done and the kids are where they should be, this could balance out.

I understand that East Mersea is being left out of this study because they bring a lot of money to the board by enrolling students from another board. Gore Hill has the potential to do the same, if it's still there.

I would also like to reiterate my thoughts on the Gore Hill property. The size of the property could easily accommodate a larger student population, even if that means a new larger build, with a new parking lot. There would still be room for a large blacktop, and huge playground. The outdoor spaces we have (outdoor classroom, butterfly garden, walking trail, and all the other things that have been previously mentioned by many parents) cannot be man-made to fit in town on a smaller site. To let this valuable property go unutilized would be a waste.

I'm proposing a wait-and-see approach. Adjust the boundaries and send new enrolments where they should be going. Get rid of the areas where two busses are travelling down the same street to take kids to two different schools. Let the French Immersion program begin, and grow. Let things settle and re-evaluate. Put a contingency plan in place for a couple of years down the road. Make the contingency plan public, and take action if and when required.

I sincerely hope that your open-mindedness continues through to the end of this study and that our pleas aren't falling on deaf ears.
