1. **THAT EFFECTIVE SEPTEMBER 1, 2015, BOUNDARIES ARE ADJUSTED FOR HETHERINGTON, Dr. DAVID SUZUKI and PRINCESS ELIZABETH PUBLIC SCHOOLS, AS:**

PRINCESS ELIZABETH:

NORTH: DETROIT RIVER

EAST: JEFFERSON BLVD (BOTH SIDES NON INCLUSIVE I.E. BOTH SIDES OF JEFFERSON REMAIN AT SUZUKI)

SOUTH: VIA TRACKS

WEST: GEORGE AVENUE (BOTH SIDES)

Dr. DAVID SUZUKI:

NORTH: DETROIT RIVER

EAST: LAUZON ROAD (west side only)

SOUTH: VIA TRACKS

WEST: JEFFERSON BLVD (BOTH SIDES INCLUDED)

HETHERINGTON:

NORTH: DETROIT RIVER

EAST: WINDSOR/TECUMSEH MUNICIPAL LINE EAST OF RENDEZVOUS

SOUTH: DILLON DRIVE WEST TO JARVIS. THEN WYANDOTTE STREET EAST TO LITTLE RIVER (THE ACTUAL RIVER NOT THE ROAD). THEN DOWN THE LITTLE RIVER (THE ACTUAL RIVER NOT THE ROAD) TO THE VIA TRACKS, WEST TO LAUZON ROAD

WEST: LAUZON ROAD (east side only)

2. **ONLY STUDENTS CURRENTLY ATTENDING Dr. DAVID SUZUKI PUBLIC SCHOOL, HETHERINGTON PUBLIC SCHOOL and PRINCESS ELIZABETH PUBLIC SCHOOL AS OF THE 2014-15 SCHOOL YEAR, WILL BE GRANTED A LIMITED EXCEPTION, WITHOUT TRANSPORTATION, TO REMAIN AT THE RESPECTIVE SCHOOL UNTIL THE COMPLETION OF GRADE 8. ALL NEW STUDENTS INCLUDING FUTURE SIBLINGS OF CURRENT STUDENTS, REGISTERING FOR SEPTEMBER 2015 AND BEYOND, WILL FOLLOW THE NEW BOUNDARIES.**
3. **BASED UPON AUTHENTICATED HOME ADDRESS: ALL STUDENTS NEWLY REGISTERED FOR SEPTEMBER 2015 WHO RESIDE IN AN AREA TO BE TRANSITIONED TO A NEW LOCATION, SHALL BE PROVIDED A LETTER FROM THE PRINCIPAL ADVISING OF THE CHANGE.**
4. **THAT THE PRINCIPALS OF THE SCHOOLS, IN CONSULTATION WITH THEIR SCHOOL COUNCILS, WORK WITH SENIOR ADMINISTRATION TO IMPLEMENT AND COMMUNICATE THE CHANGES.**
