As a parent of a child with special needs who has been shuffled from school to school since he was 5 years old, the possibility of having to change schools again is disconcerting. I truly hope that you strongly take into consideration that environmental change and re-adjustment is NOT an easy thing for a child who has a disability. I am hoping that I can advocate on behalf of all parents with special needs, by saying that children with such difficulties need to remain in a stable environment where change is not constantly introduced.

In my particular situation, I re-located my family more than 1100 km from here in order to have peace of mind and to have my child attend a school where such changes would not occur. I therefore ask that in the event of boundary changes, that you strongly consider that learning disabled children who often present anxiety and social adaptation issues, not be reloacted to another school.

We moved to Windsor 2 years ago and purchased our house at 3138 Leisure Cres., Windsor, n8r0a2, specifically to ensure that we were in the French immersion boundary to be able to go to TVA. WE are closer to TVA than Forest Glade elementary school. We live literally on the border off of Banwell.

TVA is he only school he as ever attended. He loves TVA and is always excited for school. My concern is with the proposed boundary change for TVA. We will now be outside the boundary in 2014 . He is a very bright child but struggles sometimes socially. He becomes very nervous and exhibits anxiety when confronted with new social situations. He identifies all of his classmates as friends. Will he be able to attend TVA when this change comes into effect? I am very worried what this change will mean if he has to switch schools. This could be a major set back for his early development. If you could please let me know what this change means for us, or let me know if there is anyway we can continue with TVA, it would be greatly appreciated. Thank-you for your time.

Dear School Board Administration, Tecumseh PARC committee members and School Board Trustees,

I appreciate having the opportunity to offer my input regarding the PARC recommendations for Tecumseh. I am a parent of two children who will be affected by the recommended boundary change for Tecumseh Vista. My children attend Vista in the French Immersion program and are currently in JK and Grade 2. My son who is in Grade 2 now, was moved to Vista from McCallum two years ago. He was very happy at McCallum and was reluctant to leave. However, with the promise of a new school, close by to our house which reduced his time on the bus by half, we were able to smooth it over and get him excited for his new school. He is a very shy boy and since he started at Vista he has blossomed both academically and socially. Both of my children love their school and they really feel like they are a part of the Vista Vortex family there. With that being said, I know that there are challenges with Vista busting at the seams and there is no easy answer. Without knowing all the specifics, I cannot offer any suggestions of my own and I know the committee has worked very hard to come up with this solution.

My concern is not really with Forest Glade School itself, I believe that the teachers and staff there will do everything possible to make it a wonderful place for the children to learn. But according to the numbers that were mentioned at the last community meeting, it seems that Forest Glade is nearly full already and with the addition of over 200 students from Vista, will put it in the same exact predicament that Vista is in now. There are several more streets planned in the East Riverside area, west of Clover. The street that they built just last spring is already filling up with houses. There is another street they built this spring which I'm sure will fill up over the summer. These are all potential students who would be directed to Forest Glade School for both the English and French track. My concern surrounds the children who are being moved again, to a third school with the probability of moving again in a couple years time. I can't even imagine telling my children after they get settled in at Forest Glade school and make new friends that they have to move again because the school has run out of room. They will never feel like they belong to any school community because they will always be facing the threat of moving to a new school every couple of years. This is not fair to the children. I feel like even though our intentions were good when we enrolled them in the French Immersion program, we might have done them more harm than good. It almost feels like they are being punished for being different. They need stability and to be able to feel like they are a part of their school family, not just a temporary visitor.

My hope is that you will look a little further into the future for these children. I hope there is some way you can keep these kids at Vista until we can figure out a more long term solution. That way they will only face one more disruption instead of two or three. Then they can settle in and get down to the business of learning. Thank you for listening to my thoughts and concerns.

I would like to voice my concerns regarding the proposal of Forest Glade becoming a dual track school. My main concern with this proposal is capacity. Is there truly room at the school for a French Immersion program? I currently have 2 children attending (one in SK and one in grade 2), with my  $3^{rd}$  starting JK in September. My oldest will be moving up to the main site in September, so I'm more familiar with the PLC site. That being said, is there room at the PLC to accommodate grades JK – 2 for a FI? Is there room at the main site? According to the numbers I've seen, the school seems to be running at almost capacity. Where is the FI program going to go? How is this going to affect the current students of Forest Glade school? I understand many parents are upset about a possible move, especially after having moved their children from McCallum to Vista, but has anyone considered the consequences of this move to the current Forest Glade students? Yes, there is room to add portables, but I don't agree with that solution for many reasons. The way the school is set up currently, grades JK – 2 are at the PLC and grades 3 -8 are at the main site. I think this set up creates a greater sense of community amongst the students, staff and parents. If a FI program is introduced to Forest Glade School and portables are added, who will be going into them? What will happen to the sense of community at each site? Will the students in the portables feel isolated from the rest of the school?

I have read many concerns about the continued growth of French Immersion programs, but has the growth of Forest Glade school, strictly on its own, been taken into account with this proposal? Will the school be able to handle the growth of both an English and French program? I fear the answer is no. And what will happen then? To all the students? It seems to me that this whole situation is being handled in an overly expedited manner, focusing on only fixing what is broken NOW with no thought or consideration for the future. Where is the harm in taking some more time to fully assess the situation and come up with a solution addressing both the short term and long term? Sincerely,

## Good Afternoon,

My daughter attends DM Eagle Public School and is currently in the Grade 1 program. We have two other children that will be starting school in 2014 and 2016 respectively and have some questions regarding the proposal for DM Eagle school. While I understand from the meetings that the current focus is primarily on Vista Academy, Victoria, AV Graham and Forest Glade, I would like to make our concerns for the future of DM Eagle viable as well.

There is a reason why DM Eagle is continuously at or over capacity and why parents choose to send their children to this school and not to one of the other two dual track schools within district. The teachers know every student by name, the principal answers the phone when available, the secretary is always available if the principal is not, please and thank you are required, cheering for and encouraging fellow classmates is mandatory ... love literally abounds from this school. This school allows the teachers, principal and all staff the opportunity to invest in every student, and every student feels invested in because of this. This is offered primarily because of the way the teachers and principal have chosen to administer education, with good old fashion values, manners and respect...and because the capacity of the school is low enough, the teachers are afforded the opportunity to instill these fundamental aspects of teaching and life.

While it is understood and appreciated the need for managing the overall budget, this area does not require yet another large dual track school in the middle of a farmer's field. We need schools in the community, we need children going to school with their neighbours, we need schools that offer children the opportunity to ride their bike safely to and from and not require a bus or car to drive them everyday, students deserve the opportunity to be on a team without having to be an elite athlete or gifted talent in competition with hundreds of classmates for the same few spots on a team or club. Most importantly, we need to offer teachers the opportunity to invest in each student because they know each student attending their school, by name. My daughter attended a large dual track school for two years, and while her teachers were beyond wonderful, the school as a whole was chaotic and invested in the masses and not individuals, not necessarily by choice, but by sheer need to manage a school with that many students. MANY core values were overlooked primarily because of the need to accommodate such a large number of children within the school.

The questions I have currently are:

• If "bums in seats" are what determine the money given to support the school, why can DM Eagle not be retrofitted to bring it up to technological and maintenance standards? Clearly this school has had the necessary population and is projected to continue to have the required capacity to be provided the dollars to support this. The school is over populated because parents want their children going to school in the community which they live. If there is to only be one "small school" left, let it be DM Eagle, and outfit it accordingly.

• What happens to these schools once they are vacated? Now there is potential for derelict buildings in the community.

What is the approximate time line should DM Eagle be closed?

Has there been any support, other than budgetary, for the closure of DM Eagle (have parents expressed interest in closing the school to build a new dual track school or merge with AV Graham, or is this strictly a recommendation to accommodate budget requirements?)

Again, it is fully understood the need to meet budgetary requirements and it is encouraged to explore all options, but DM Eagle has, and will continue to have, the population to have money allotted to the necessary upgrades required to keep it where it is within the community and I firmly believe that should be considered
