1. Call to Order

The meeting was called to order at 1:28 pm. due to technical difficulties.

2. Approval of the Agenda

4. Business Arising as a Result of the Minutes

M. Matte-Gasparovic had a question regarding the *My Way* presentation from the November 2020 SEAC meeting. She asked how non-verbal students communicate "My Way". K. Sweet responded that the team decides on an appropriate response for the students (e.g. double-tap

with hand, thumbs up for O.K.). The skill level of the student will determine how they demonstrate MyWay.

5. <u>Update on Speech and Language/Psychological Services</u> – Dr. M. Crundwell

Psychological Services staff continue to run and offer all services that were offered in previous years. Staff work on a two-week schedule. One week in school with students (attending only two schools per week) and consultation with staff. The second week is used for virtual consultations, preparing for assessments, sending out questionnaires, and doing feedback. We currently have 153 assessment started or consent has been signed. 45 are completed so far. There have been 275 students assessed so far this year. The Psychology staff ask schools to not adjust the priority list based on the cohort that students are in. We are offering in-person assessments, using required PPE. Space has been rented to accommodate social distancing for students in cohorts C and D, for parents who are uncomfortable bringing their child into the school. Virtual assessments are also being done and we have purchased resources needed to complete these assessments. There are currently 8.5 Psychologists plus Dr. Crundwell who also services two schools.

The Board has 9.0 Speech and Language Pathologists (SLPs). The SLPs are on a three-week rotation. The first two weeks, they are at schools, consulting with teachers and administrators, completing assessments and providing direct intervention for students (usually for early years and gr. 1). They also do small group interventions. The Board also has 1.5 Communicative Disorder Associates (CDAs) who go to two schools per week to provide individual and small group interventions. The CDAs are supervised by an SLP. Week three is for office time, writing reports, contacting parents, and for virtual assessments and interventions. Thera Platform, which is aimed to help students with their articulation, receptive and expressive language, auditory processing, reading, cognition and problem solving, and social skills, will be used for virtual consultation in January 2021. Currently, our SLPs and CDAs are providing services to 954 students in all cohorts within our Board.

Our Educational Coordinators developed a series of webinars to build capacity for teachers in the event they have to pivot to remote learning. These webinars were developed for our Learning Support Teachers, Rise Teachers, GAINS Teachers, STEPS Teachers, and Education Support Staff were also able to attend. These webinars have included topics such as:

- Introduction to Microsoft Teams
- Features within Teams such as Class Notebook and Staff Notebook
- Resources and Activities that can be used to teach remotely
- What a typical school day would look like in the virtual classroom
- How to conduct a virtual field trip and invite the family along
- How to use the Diagnostic Reading Assessment virtually

Special Incidence Portion (SIP) Funding for 2020

- The Special Incidence Portion (SIP) is one of the six allocations that make up the Special Education Grant, which is part of the Grants for Student Needs. SIP is intended to support students with extraordinarily high needs who require more than two full-time staff to address their health and/or safety needs, and those of others at their school.
- In previous years, the SIP allocation has been based on claims submitted by school boards. For the 2020-2021 school year, regulatory amendments to Ontario Regulation 489/20 will not allocate 2020-2021 SIP funding through a temporary formula-based mechanism rather than through the existing claims process.
- These amendments will provide school boards with a 2020-2021 starting SIP allocation based on the highest amount of either:
 - ➤ Their 2019-2020 SIP funding allocation
 - ➤ An average of the previous three years (2016-2017 to 2018-2019)
- A growth rate of 5% will also be applied to the 2020-2021 starting allocation of each board. Boards that have challenges managing within their allocations should work with their regional offices to ensure that eligible students receive appropriate supports.
