1. Call to Order

2. Land Acknowledgement

6. Special Education Presentation

• High School Students with Intellectual Disabilities Integration Project Presented by J. Newton. The High School Students with Intellectual Disabilities Integration Project (HSSIDIP) is an employment-training program designed to help students with intellectual disabilities or autism transition into the workforce. The program addresses the high unemployment rate among these students by providing structured work placements in federal organizations. Students participate in two 24-week placements, performing authentic tasks and receiving support from support staff. The program aims to demonstrate that with adaptive measures, these students can integrate into the workforce and contribute meaningfully to society. Eligibility criteria include between 16 and 21 years old, having an Individual Education Plan, and demonstrating potential for workplace autonomy. The goal is to expand the program to more candidates in the coming years, with hopes of full-time employment for participants.

7. Special Education Updates

- Update on Restructuring Supports for Special Education by C. Mills.
 Since our last meeting, several developments have occurred rapidly. We have consulted with the Ontario Secondary School Teachers' Federation (OSSTF) Educational Support Staff regarding the revision of the DMSW role. A consultation with Superintendent J. Bell focused on student well-being and next steps, as identified in parent phone calls. In February, we met with the Elementary Teachers' Federation of Ontario (ETFO) to discuss key themes from their members. Following that meeting, we held a consultation with the Learning Support Teachers. Principal consultations were also conducted in early March. Our next steps include:
 - Consulting with stakeholders
 - Continuing to review school profiles
 - Reviewing our current resources
 - Exploring other resources and community partnerships
 - Consulting with other school boards
 - Applying for professional development for Year 2 of Universal Design and Differentiated Instruction

Professional Development Updates

L. Bates shared they received good feedback from the presentation with Dr. Angela Burke. Coming up next month the focus is not necessarily on Special Education, but will include

Vaping and Cyber Security. Our team met to discuss future professional development with a focus on Ableism and the importance of that message.
