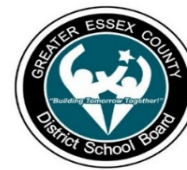

COOP Registration and General Information

Registration Without Placement: April 1, 2019 to May 10, 2019

Registration With Placement: April 1, 2019 to June 14, 2019

Secondary Students MUST apply through their Guidance Office

Required Documents for Registration	<p>Mature students (at least 18 years old, and out of school for 1 year)</p> <ul style="list-style-type: none"> Two pieces of id (birth certificate/passport & photo id). Immigration papers or proof of citizenship. <p>All students</p> <ul style="list-style-type: none"> Complete high school transcript, including final marks from 2nd semester for non-GECD students Any additional post secondary documents.
Preplacement	<p>Students accepted into the summer learning program will be contacted by the teacher as to the date and location of the preplacement (first class).</p> <p>Preplacement Locations</p> <ul style="list-style-type: none"> Mason Education Centre Unemployed Help Centre Leamington District High School
Expectations	<ul style="list-style-type: none"> Students and their families need to be aware that the pace and the volume of work are demanding as one credit involves 110 hours of placement. There is no LST or guidance support available. The student is expected to provide his/her own transportation to and from the work location. Transportation is not provided by the school board. The maximum number of days absent for valid reason is two (per credit). Upon the third absence, you will be withdrawn. No Exceptions. The student must attend the pre-placement meeting or he/she will be removed from class. You will be contacted with details by phone. All placements must be completed by Aug-09-19 <u>NO EXCEPTIONS.</u>
Condition of Acceptance	<p>Students are subject to the GECD Code of Conduct.</p> <p>Students who do not follow the code of conduct will be withdrawn from school.</p>

Student Profile

The Coop program is a full-time program that runs thru Adult and Continuing Education.

Most students will work towards earning 1 or 2 credit coop although some exception will apply.

What Student Fits Best for COOP?

- ✓ A student who needs only 1 or 2 credits to graduate.
- ✓ A student who needs 1 or 2 credits to get back on track with their scheduled graduation year.
- ✓ A student who would like to try coop, but cannot fit it into their academic schedule.
- ✓ An SHSM student who cannot fit their coop requirement into their academic schedule.
- ✓ An OYAP student who is on his/her work placement and can tie coop to an existing credit(s).

Program Requirements

Eligible students need to have completed 2 years of high school and earned at least 12 credits; by the end of the semester.

- ✓ It is preferred that the student has earned either English credits, the grade 10 GLC credit, or a GLS/GLE credit that has not been previously used to attach to a coop credit.
- ✓ Student has not yet earned 30 credits.
- ✓ Exceptions to any of these requirements may be considered in cases of an exceptional earned-match to a placement.
- ✓ It is strongly recommended that adult students complete any required academic courses before applying for coop.
