5. Coding and Robotics in GAINS/STEPS – Dr. Christine Daigle, Jennifer Newton, Amanda Laforet

- Robotics Pilot Project in Self Contained Classrooms in Partnership with JMCC School Authority
- Research piloted in 2018/2019 at Riverside Secondary and King Edward
- Trends found were more focus, more time on task, more eye gaze
- This school year 2019/2020 study at Talbot Trail for bigger sample size
- JMCC School Authority assisting with implementation of project, devotes one day a week to the project
- Superintendent has reached out to other school boards to see what they are doing with robotics and complex special needs students
- Why use Robotics?
 - Exciting
 - Allows students to demonstrate their learning
 - Keeps pace with Coding to Learn Project
- Elementary and Secondary Robotics Lending Libraries for STEPS/GAINS classrooms
- JMCC School Authority also has a lending library that both STEPS/GAINS can utilize with different equipment
- Ongoing after school PD session occurred once a month, 5 more this school year
- Presentations at ASET, SERCC, RSEC
- Pursue partnership with Code to Learn

Following the presentation, SEAC members and visitors were invited to test out and play with some of the technology that is being used in our schools.

PD Update:

- December 11, Gifted Experiential Learning Camp at the University of Windsor
- Secondary STEPS IEP Audit coming in January
- After school IEP workshops are being held once a month
- Planning for PD for the remainder of the school year

OnSIS Reporting Data:

M. Wilcox went over the statistics from our October 31, 2019 Ministry reporting. Included in these statistics were the number of Special Education students (both elementary and secondary), exceptionalities and placements. The largest identification across the board is Learning Disability, which is consistent with school boards across the province.

M. Wilcox reviewed the Autism category for the elementary panel, and shared that of the 174 students formally identified with Autism in the GECDSB, 98 are in the regular classroom with indirect support, 6 are in the regular classroom with withdrawal support, 20 are in the RISE programs (partial support) and 50 are in our GAINS programs. He also shared that of the 759 who are formally identified as Multiple, 170 of those students have Autism as their comorbidity and many of these students are receiving programming through our RISE and GAINS programs.
