1. <u>Call to Order</u>

Lynn McLaughlin called the meeting to order at 1:00pm.

2. Election of Chairperson and Vice-Chairperson

# **Election of Chairperson**

#### 6. Business Arising as a Result of the Minutes

Draft letter to the Ministry of Education.

L. McLaughlin reported that Dr. Pyke spoke with the agency regarding key people attending transition meetings. The response was that the practice of sending staff had not changed. There were cases in the fall that due to circumstances, their staff were unable to attend. L. McLaughlin's recommendation was not to send the letter until we monitor further attendance from community agencies. She suggested that we reach out to the agencies with any concerns if and when they occur. L. McLaughlin will speak to Dr. Pyke regarding communication between the school and agencies and ensuring staff that have been with the student daily attend the meetings whenever possible.

## 7. Special Education Presentation –

Jennifer Newton, Educational Coordinator for Herman Academy Secondary School and Sandra Pizzo, Department Head for the STEPS Department, shared the experience for students in STEPS on their way to the Provincial Special Olympics in Niagara Falls. The provincials will feature 20 teams from across the province, Canada, and the United States. Overall, the provincials will involve over 900 athletes and coaches this year.

# 8. Review of the Special Education Website

It was decided by the committee that a sub-committee consisting of Trudy Richards, Kim McKinley and Susan Smith review the Board's Special Education website and bring back suggestions for changes.

# 9. <u>Special Education Update</u>

#### **Connections**

The memo has been distributed to Principals with students that are returning from IBI regarding requests from parents for additional school days. As children are identified at other schools, we will ensure these Principals are informed as well.

The Instructional Therapists who do the IBI with the children at Thames Valley Children's Centre, have asked for some in-servicing on Early Years. Thames Valley would like their therapists to see how our teachers are transitioning. T. McCarthy will be in touch with the teacher of our Early Years Demo Site at Glenwood to help support this.

## Reading intervention Pilot

The GECDSB presented at the Toronto Learning Disability Reference Group. The Board is hearing fantastic reviews from the Learning Support Teachers on this pilot project.

A presentation for SEAC can be arranged in the future to hear from teachers their experiences and student responses to this pilot. It was suggested that the information be shared with the community agencies and organizations as these programs could be an option for them.

# **Professional Development Update**

M. Wilcox informed the committee of the planned PD for the next month. Including workshops on Fetal Alcohol Spectrum Disorder, IEP Writing, Locally Developed Credit Course (LDCC) training for secondary teachers and the list of workshop on the February 17<sup>th</sup> professional development day for Educational Support Staff. We finished IEP audit with one third of our schools.

#### **SEA Process Review**

L. McLaughlin reported that on January 19<sup>th</sup> there is a meeting with Information Technology, a Secondary Learning Support Teacher, Elementary Learning Support Teacher and Special Education to review the work flow involved with a SEA claim. L. McLaughlin will inform SEAC of any changes to the process.

B. Cook mentioned that GECPIC was discussing how to get the information out for upcoming events. The information is on the website but if there are any flyers they can be sent to M. Goyette who can email them to SEAC members.

M. DeBruyne informed the committee that Western Secondary School is the venue for the Night to Shine on February 10<sup>th</sup>.
