<u>Business Arising as a Result of the Minutes</u>
M. Wilcox revisited discussion on BMS training in partnership with Autism Ontario. J. Matte-Gasparovic will be included in the training sessions. This will most likely take place in the spring.

6. After School Skills Development Program (Autism) – Samantha Mulcaster

S. Mulcaster reviewed the upcoming After School Skills Development Program for Students with Autism Spectrum Disorder. The "My Way" program was developed to provide a meaningful school experience for students currently referred for behavioural intervention support services requiring individual functional skill growth, in order to increase engagement, promote independence and decrease the occurrence of challenging behaviour. The program (as outlined by Greg Hanley, PhD) will teach a student how to ask to have all of their wants and needs met with one easy response to replace the challenging behaviour, and will be followed with the slow re-integration of the typical classroom expectations. A Registered Behaviour Technician has been hired to follow through with the program by working with students and staff before and after school, and during nutrition breaks.

M. Wilcox added that there were 10 pilot boards across Ontario that had After School Skill Building programs. It is our hope to have 5 students complete the program by the end of June. It will depend on the student and their needs. Transportation for students is not required as observation of students will happen during the regular school day during nutrition breaks. The Ministry has provided 3 years of funding for this project.

M. Wilcox and K. Sweet have gone through the Special Education Plan, flagging what needs to be revised. They will bring these revisions to the committee in February to start work on the plan. Budget information will most likely come closer to the end of the school year.

M. Wilcox read a letter from the Durham School Board regarding the inactive status of the Ministry Advisory Committee on Special Education (MACSE). B.
