1. Call to Order

M. Fuduric called the meeting to order at 1:03 pm.

2. Approval of the Agenda

3. Approval of Minutes

4. Business Arising as a Result of the Minutes

K. Wilson revisited the reverse integration for STEPS/GAINS. K. Wilson said that STEPS/GAINS students would like to be part of a regular classroom (e.g. drama, music, art). She added that there is research that reverse integration is not positive. M. Wilcox requested that K. Wilson pass on this research to SEAC. M. Wilcox added that we do have many great things going on in our schools, both integration and reverse integration. He gave an example of an overnight trip with Belle River DHS STEPS and one of the history classes. This was very successful!

5. Speech and Language Delivery Model – Dr. Marc Crundwell

SLP Scope of Practice

• The SLP Scope of practice has been refined for the 2019-2020 school year – it continues to be based on an early assessment and early intervention model to support language development

- The primary focus of the model is the Early Assessment Early Intervention Model in the JK-Grade 1 program in which the SLPs will provide Tier 1, 2, and 3 services within these classrooms as prioritized with school administration. This will include teacher and staff consultation, small group in-class interventions with a focus on "pull in" services and not pulling out students from class; formal assessments as required, ongoing informal assessments, and articulation therapy (a student may receive two blocks of 8 sessions between JK and Gr 1).
- In a number of schools the CDAs, under the supervision of a SLP, will provide increased small group interventions in the JK to Gr 1 classrooms to support language development
- SLPs will also provide ongoing services as a secondary part of their scope for students between JK-grade 12
 which include consultations, meeting with school administration and LSTs, GAINS and STEPS consultations,
 RISE consultations, assessments on a case-by-case basis, and articulation therapy for one block for students
 in grade 2 who had previously receive two blocks in JK-grade 1.
- Children in grade 2 and above will not receive direct therapy interventions
- Referrals for selective mutism and central auditory processing disorders will follow a consultative multidiscipline team model
- French Immersion schools will continue to support Tier 1 SLP services, while students requiring language support or functional communication will receive consultative services (no direct intervention)

Professional Assessments Update:

Professional Assessment funds were used to purchase materials for SLP assessments, develop a tracking system with our I.T. department, and to complete 69 psychological assessments at the end of August. This does not include the Jordan's Principle assessments that we have helped families apply for through Toni Lauzon. Jordan's Principle has resulted in hiring additional ESS, provided families funding to get assessments completed, and purchase sensory equipment, technology, training, etc.

7. New Business

Tim McCarthy, Behaviour Management Specialist, who has been with the board for 36 years, has retired. Samantha Mulcaster, who is a Board Certified Behaviour Analyst, will be moving into this role.

PRO Grant

This grant is available every year. There is specific criteria to follow when submitting applications. GECDSB has been given funds and staff within our board can apply for funding. M. Wilcox specifically asked if anyone would like to be on the committee that approves the PRO Grant requests. No one expressed interest. There is funding available for SEAC. In the past, funding has been requested for support for indigenous families. The mental health nights were also funded through this grant.
