4. Business Arising as a Result of the Minutes

5. Jordan's Principle

J. Newton and T. Lauzon presented a power point presentation on Jordan's Principle which is a child first and needs-based principle used in Canada to ensure that First Nations children living on and off reserve have equitable access to all government funded services. They explained key points such as background, process, special education needs, and the number of applications in 2017/2018. Out of the 43 applications that were received in the 2017/2018 year, 30 students were able to get help, with resources such as SEA equipment, psych assessments, etc.

Jordan River Anderson, a First Nations child, is the reason Jordan's Principle was created. Jordan waited 5 years for funding to be approved and it ended up being too late for him. Jordan's Principle pays for the need for indigenous children so there is no delay in funding.

T. Rilett asked if Jordan's Principle would fund these activities. M. Wilcox suggested that she ask T. Lauzon about this.

K. Wilson – there is a support group at Glengarda on the first Thursday of every month during the school year from 1 - 2:30 p.m. The support group is for parents, regardless of the age of their child(ren).

M. Wilcox – The IEP and More evening was held on October 1st. There were about 70 parents that attended this presentation. This speaks to the need to understand the IEP process. Our educational coordinators work very hard to help parents understand the process. K. Wilson added that this was the first year that the presentation information was shared on social media and this most likely contributed to the increased attendance.
