### 5. Presentation

Right to Read Report - OHRC Report Summary Update

M. Wilcox shared a power point presentation with the SEAC committee outlining the OHRC Right to Read Report which is a public inquiry into human rights issues affecting students with reading disabilities. School boards, faculties of education and members of the public were consulted for input on this report. The report covers the findings and recommendations of the following:

- curriculum and instruction;
- reading interventions;
- accommodation;
- professional assessments, and;
- systemic issues

The power point, created by the Science of Reading Committee, was shared with school administrators in February 2022 as an update and indication of the board's plan to build teacher capacity across the system. Though absenteeism due to COVID has significantly impacted the board's ability to implement large scale PD initiatives around reading there have been opportunities for smaller PD sessions at individual schools. There has also been ongoing support for the Science of Reading by the board which includes messaging for staff meetings, a professional learning video series, administrator capacity building sessions, and Heggerty Q & A sessions for LSTs and Coaches.

The board is looking at implementing system wide diagnostics to identify students who are struggling with reading and we are hoping that PPM 155 is revised by the Ministry of Education which would promote this plan. These diagnostics will show if children are learning phonics and letter sounds. Currently, Lexia is used for Tier 2 reading intervention. Lexia Core5 is an intuitive online program that scaffolds support for students and alerts teachers through the teacher dashboard that a student in struggling in a specific area of reading. It also provides individual and small group lessons for the teacher to implement with students. Empower is used for Tier 3 reading intervention (it was created by Sick Kids' Hospital) to support students with more severe reading challenges. The board has been using these programs for approximately 5 years and both are highly recommended interventions supported by the OHRC's Right to Read report and are on the Ministry of Education's approved intervention list.

There has been excellent PD created in collaboration with the Program Department and the Special Education Department. Tammy Wilcox, Education Coordinator, and Melinda Hinch, Speech and Language Pathologist, worked to create PD videos aligned to the Science of Reading for administrators and educators. The Science of Reading Committee has also purchased resources (literacy kits) for all Early Years and Primary teachers and these have been distributed. Kits are coming for ELL and RISE classrooms and will be distributed.

# 6. Special Education Plan Review - Standards 7 to 11

K. Sweet went over the revisions in Standards 7 to 11 and welcomed feedback from the SEAC committee. The Standards covered were:

SEAC discussed moving STRIVE Conference to the fall from the previously determined date of May 24, 2022 as it is Learning Disabilities month and it would be nice if the event coincided with the designated month. Concerns were brought forward about the conference conflicting with EQAO testing in May. Both heavily depend on Learning Support Teacher participation to be successful. Another benefit to deferring would be that we may be able to hold STRIVE in-person in the fall which would be more engaging for the students. The SEAC committee agreed that the move to the fall would be a better option.
