## 5. Presentation

Right to Read Inquiry (Executive Summary) Ontario Human Rights Commission (OHRC) The committee has decided to defer this presentation until next month's meeting. There was PD in the spring with Elementary Administrators around the Science of Reading. Empower and Lexia are aligned with the Science of Reading for tier 2 and tier 3 interventions. Program and Special Education worked together to develop PD for Early Years, Primary, LST and RISE teachers. We purchased the Heggerty curriculum for all LSTs and they are piloting this in Early Years and Primary grade classes. Science of Reading (SOR) kits were created for Early Years and Primary classrooms. T. Wilcox, Special Education Coordinator, and M. Hinch, Speech and Language Pathologist, have been going out to schools to work with teachers to build capacity around teaching students to read. Our board's response to the Right to Read Inquiry is on the Board website.

## 6. Special Education PD Update

- Autism AQ (teachers) about 18 teacher signed up for this course. We had previously had over 50 teachers who participated in this course when it was offered.
- Self-Regulation Certificate (ECEs) about 20 ECEs are participating focuses on how the body and brain stress system works in children. The funding for ECEs to participate in this course has come from the Ministry of Education.

K. Sweet went over the revisions in Standards 1 to 6 and welcomed feedback from the SEAC committee. The Standards covered were:
