Letter from the Durham District School Board regarding Needs-based Funding/Services for Children with a Diagnosis of Autism – New Pilot Program, was reviewed at the SEAC meeting on June 8, 2021. J. Matte-Gasparovic offered to take the information back to Autism Ontario and review with the committee at the SEAC meeting on September 14, 2021. In consultation with the

local Autism Ontario chapter, the recommendation to the GECDSB SEAC, was a "no stand" position on this new pilot program at this current time mainly due to the election taking place, which may change the funding model yet again.

5. Special Education Update

Lexia Update

 Lexia Core5 licenses continue to be available in all of our elementary schools as a Tier 2 reading intervention.

Empower Update

Empower is continuing in all of our schools as a Tier 3 reading intervention. Teachers new to
the role of Learning Support Teacher (LST) will be receiving training from Sick Kid's hospital
at the end of this month after re-organization. Coaching from Sick Kid's continues for those
teachers who are Empower trained.

Annual Accessibility Report for 2020-2021

- The goal of the Accessibility for Ontarians with Disabilities Act (2005) is to have an accessible Ontario by 2025.
- GECDSB falls in the 50+ Public Sector employee organizations.
- We have to have a 5 year Accessibility Plan and provide an annual accessibility status report each year which is available to the public on our website in an AODA compliant version.
- After it is reviewed with SEAC for feedback, the draft will go back to the Accessibility Committee.
- We are looking to establish an Ad Hoc committee with staff with disabilities to provide input on accessibility issues at the school board and to provide insight into barriers that exist.

FNMI Empower Tutoring

- This year, based on feedback from the Indigenous Education Advisory Committee (IEAC), the Special Education Department in conjunction with the Program Department, will be providing the opportunity for self-identified FNMI students (Grades 6-8) to participate in after school Empower tutoring.
- This opportunity will be provided to self-identified FNMI students who are formally identified with a Learning Disability in the area of reading.
- Based on student and family interest, we may be able to expand the criteria to give the opportunity to other intermediate self-identified FNMI students who have reading struggles who are not formally identified.

Summer Psychological Assessments Update

- Through the Return to School transfer payment agreement we received from the Ministry of Education, we were able to utilize funding to have additional psycho-educational assessments completed over the summer.
- We completed 53 assessments through this funding
- Dr. Crundwell completed an additional 6 assessments over the summer
- While this did not eliminate our current wait list, it was effective in reducing the wait list in some of our schools with high-needs.

Enhanced Transition Program in Secondary Schools

- This summer during the month of August, we were able to provide an Enhanced Summer Transition program in all of our secondary schools.
- Students moving from Grade 8 to Grade 9, formally identified with an LD and students who
 attend MAPS programming were provided an opportunity for an individualized appointment to
 tour their new school. Each student and a family/caregiver were provided with the opportunity
 to:
 - Tour the school with the Child and Youth Worker (CYW)

Science of Reading (SOR) initiative with Program Department

• At the GECDSB, we are committed to providing an equitable inclusive responsive and comprehensive literacy program based on the Science of Reading (SOR), that utilizes assessments and instructional practices to ensure every student has the fundamental right to learn and read. The Special Education Department in partnership with the Program Department will be building teacher capacity in the area of reading instruction based on the research from the Science of Reading (SOR) through professional development this year. Focus will be on the 5 big ideas in reading: phonemic awareness, phonics, fluency, vocabulary and language comprehension. This fall, a four-part learning series will be held for administrators, primary homeroom teachers, learning support teachers, RISE teachers, ESL teachers and coaches (ESL & Early Intervention).
